**Lubbock Economic Development Alliance, Inc. Agreement with
ArmTech Insurance Services, Inc.
For the period from September 1, 2011 through August 31, 2012**

Background:

The Lubbock City Council established the Lubbock Economic Development Alliance, Inc. (hereinafter referred to as LEDA) to promote local economic development and stimulate business and commercial activity in Lubbock and the surrounding area. To this end, LEDA entered into a performance agreement with ArmTech Insurance Services, Inc. (hereinafter referred to as ARM) on August 15, 2011.

The terms of the agreement provide incentives to ARM for the creation of new jobs. The general terms of the agreement allow ARM to receive up to \$84,000 for the creation and maintenance of twenty-four (24) new full-time jobs from September 1, 2011 through August 31, 2016. ARM will earn incentives ranging from \$2,500 to \$10,000 for each job created according to an annual compensation schedule, and these incentives will be earned in one-fifth (1/5) increments as of each annual measurement date.

Objective, Scope and Procedures Performed:

Our objective was to determine if ARM met the job creation requirements of their agreement with LEDA. A summary of the procedures used is as follows:

- Reviewed the pertinent contract.
- Reviewed employee census data indicating names, dates of hire, dates of termination, work locations and compensation as of 9/1/11 and 8/31/12.
- Obtained the Texas Workforce Commissions (TWC) reports for quarters ending 12/31/11 through 6/30/12 and semi-monthly payroll reports for the pay periods of September 2011 & July-August 2012.
- Reviewed wages reported on the TWC reports to verify annual compensation levels and to corroborate dates of hire and/or termination.
- Discussed questions and issues raised as a result of the above steps with ARM personnel.
- Discussed agreement interpretations with LEDA personnel.

Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

Results and Conclusions:

Per our review of the above data:

- ARM had ninety-seven (97) full-time Lubbock employees and one (1) part-time Lubbock employee as of September 1, 2011.

- ARM had one hundred seven (107) full-time Lubbock employees and three (3) part-time Lubbock employees as of August 31, 2011.
- Of the net increase of ten (10) full-time positions in the Lubbock office, the following met the specific compensation requirements for the various levels of incentives:

Based on the above, ARM is currently entitled to receive one-fifth (1/5) of the total first-year earned incentives of \$62,500, or \$12,500.
